We provide special services to reach Latino, African American, and Asian/Pacific Islander populations.

We strive to make more people aware of the services available for those facing this disease and the benefits of early detection. We also engage the media and our Alzheimer's Greater Los Angeles "champions", encouraging them to advocate, donate, and participate to move this cause forward.
