



## Health + Safety

The health and safety of our community, staff, and volunteers is our first priority, and we will continue to follow local and national recommendations. We have recently updated our health and safety protocols to adhere to LA County Public Health guidelines. Please see below for more details.

The following protocols are required for all attendees, staff, volunteers, talent, and crew:

- **Proof of vaccination or a negative COVID-19 test taken within 72 hours of the festival will be required for everyone attending.**
- “Fully vaccinated” means it has been at least two weeks after your final dose of a vaccine authorized by the World Health Organization (WHO) or the U.S. Food & Drug Administration (FDA).
- Attendees will need to either bring your physical vaccination card, a picture of your vaccination card, or a digital vaccination record. All California residents may request a digital vaccination record at [MyVaccineRecord.cdph.ca.gov](https://myvaccinerecord.cdph.ca.gov).
- Instead of a vaccination record, attendees can also present a negative COVID-19 test (PCR or antigen) taken within 72 hours of the festival. Attendees will need to bring either a physical COVID-19 test result, emailed result, or picture of results showing a negative diagnosis as well as the date and their name.
- Stay home if you are sick or have COVID-19 symptoms, have been in contact with someone known to be or suspected to have been infected with COVID-19 within the last 10 days, or if you are subject to a quarantine or isolation order.
- Sanitize your hands frequently. Wash your hands with soap and water for at least 20 seconds.
- Attendees who are not fully vaccinated must wear masks while at the Making Memories Festival.
- All guests, regardless of vaccination status, should wear masks while near the concession area and while waiting in line for food trucks.

The Making Memories Festival will implement additional safety protocols such as physical distancing, providing masks upon request, hand sanitizing stations throughout the park, and more.

We encourage all attendees who are able to get vaccinated, to do so, and are proud to say that 100% of the Alzheimer’s Los Angeles staff is fully vaccinated.

## Vaccinations Available

Alzheimer's LA is excited to announce that we are partnering with REACH LA to help keep our community safe. A vaccine clinic will be on site at the Making Memories Festival with the Mobile Vaccination Team (MVT) of the Department of Public Health (DPH) to safely administer the COVID-19 vaccine. Scheduled appointments as well as walk-up appointments will be accommodated.

- Vaccinations will be available from 12-4pm

- If participants are unable to make an appointment in advance, on-site registration will occur. Identification with name and date of birth preferred, but residents without identification will not be turned away.
- 5-17 year olds receiving Pfizer will need a parent/legal guardian present AND documentation with proof of age indicating name and date of birth (birth certificate, school document, immunization/medical records, etc).
- Those receiving a first dose will be referred to [myturn.ca.gov](https://myturn.ca.gov/) to schedule their second dose
